Memorandum of Understanding for Consultancy Work

Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai and Nallamuthu Gounder Mahalingam College, Pollachi

This Memorandum of Understanding establishes the following guidelines for doing the consultancy work between Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai and Nallamuthu Gounder Mahalingam College, Pollachi for profiling the students of AMET through Psychometric Analysis for the Academic year 2020-2021 onwards.

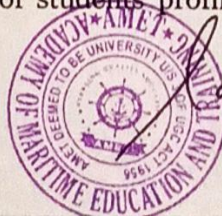
Agreement:

The Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai and Nallamuthu Gounder Mahalingam College, Pollachi, hereby agree to work together to:

1. A Three Day Orientation meeting on the various parameters of Psychometric Tests will be presented by the Team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi to the Students of Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai (in different batches) in their premises / online mode.
2. Team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi will provide and brief the students of Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai regarding the importance of students profiling through Psychometric Analysis.

3. Input Data for the Psychometric Test either Online / Offline from every student shall be collected by Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai, and the same is to be given to Nallamuthu Gounder Mahalingam College, Pollachi in the prescribed format given by Nallamuthu Gounder Mahalingam College, Pollachi. The data will be used only for the purpose of psychometric test.

4. After receiving the necessary input, the individual candidate scoring shall be done by Nallamuthu Gounder Mahalingam College, Pollachi, (within 20 working days) and some staff assistance may be required from Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai (if any).

4. The interim report will be submitted to Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai in person / in absentia (as per the convenience) by the team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi, on mutual agreement, as it is required to discuss in length the performance of students after the analysis.

5. If needed, a special venue may be arranged by Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai along with the students to discussion. It will be helpful for the team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi to meet the students and share their strengths, weaknesses, overall grade and their performance individually.

6. A Counselor is to be appointed by Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai to monitor and track the performance of the students annually and if needed they may also seek the help of the team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi.

7. The consultancy package for conducting this student profiling and psychometric analysis is Rs.78,750/- (Inclusive of all taxes) (Rupees Seventy Eight thousand and Seven hundred fifty only) and it is to be paid by Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai to Nallamuthu Gounder Mahalingam College, Pollachi.

8. This package does not include the travel, accommodation and miscellaneous expenses during the visits by team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi. It has to be separately borne by Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai.

9. The payment towards this consultancy shall be given to The Principal, Nallamuthu Gounder Mahalingam College, Pollachi. Within 60 days after the submission of the Interim Report to Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai by the team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi.

10. Deputation of at least Two Faculty from Academy of Maritime Education and Training - AMET (Deemed to be University), Chennai is needed for coordination with team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi, till this Consultancy work is valid.

11. If there are any difficulties arising on the technicalities or any other behavioral issues of the student in the psychometric level of understanding, the team of analysts from Nallamuthu Gounder Mahalingam College, Pollachi will be sorting it out.

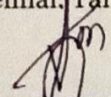
To accomplish these objectives, we will meet as and when needed for the entire MoU period, for the purposes of planning, conducting and evaluating the psychometric outcomes.
