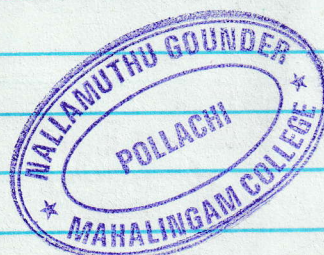

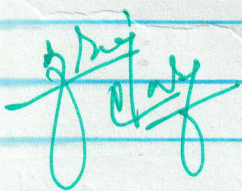


Disciplinary committee meeting was held on 30th Aug 2022 at Board Room. The following decision were taken regarding issues related with attendance lagging of students.

* It is revealed that brutal attack was happened among the students. It was noticed by Principal.

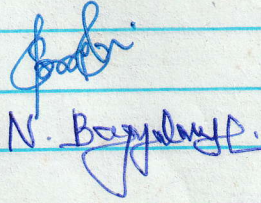

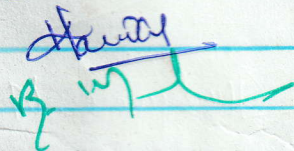

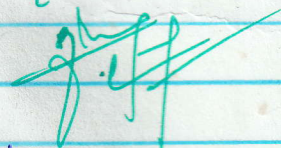
Disciplinary Committee meeting was held on 17/02/2021 at Board Room and the discussion was carried out.

The Committee formally will review all cases and will act accordingly as per the management Policy.

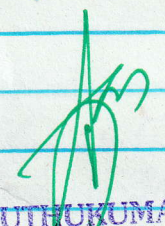

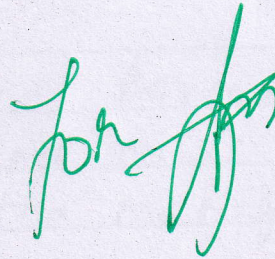

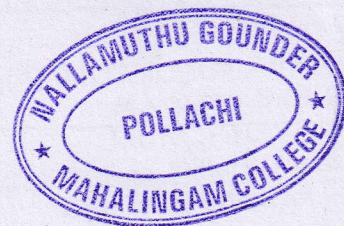
Disciplinary Committee Meeting

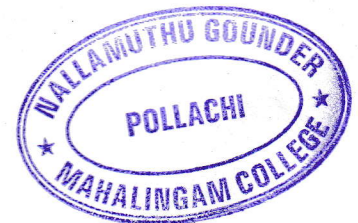
Discipline Committee meeting held on 13.11.2019 at Boardroom and discusses the following Matter (Time 11 am).

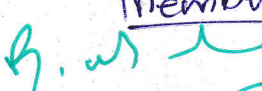
- ❖ The students shall strictly observe the disciplinary rules framed by the college which may be framed from time to time.
