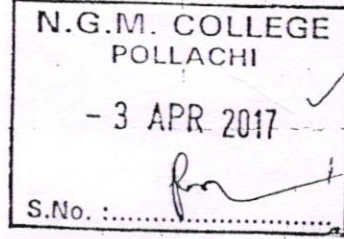

I am to inform you that the Syndicate considered the correspondence under reference together with the report of inspection of the arrangements made for the opening of the College and resolved that provisional affiliation be granted to the College for the Pre-University course in the following subjects:

- Part I, English and Tamil
Part II, (a) Mathematics, Physical Science,
Natural Science.
(b) Humanities - Logic, World History,
Commerce and Advanced Tamil,

subject to the following conditions.

1. That the total number of students should not exceed 160, they being divided in two batches of 80.

2. That the following provision may be made for the library grant.

3. That the staff requirements as mentioned by the Commission be approved.

4. That a Commissioner be sent out later in the month for inspection and detailed report.

5. That the other recommendations made by the Inspection Commission should be implemented.

6. That the management be vested in a body exceeding 9 members of which the Principal of the College will be ex-officio. The details regard to the Managing Committee (N.C.M.C. College, Pollachi - 64 Coimbatore District)

7. That the scales of pay and conditions of service also be as laid down by the University.

8. That an endowment of Rs. 5 lakhs should be made available before the college can be raised to the 3-year degree standard.

9. That steps should be taken immediately to proceed with the construction of the college buildings on the site for the 3-year degree course and that a report should be made about the progress of construction by the end of December.

Should any of the conditions be not fully satisfied, not be possible for the degree course to be started in any year of the year 1958-59 and the continuance of the affiliation is to be reviewed.

In communicating the above resolution of the Syndicate have to request you to let us have a report on the opening of not later than 1st August 1957.
