The Board Carefully & Critinized the Syllabus and resolved.

2013 - 14 syllabus:-

- (i) To include Block field work and Summer placement training in the III Semester. The marks allotted will be 50 marks for Block field work (2 credit) and 50 marks for Summer placement (3 credit). The evaluation will be only internal.
- (ii) To remove the paper on Computing and Soft Skills for Social Workers (both theory and practical) the IV Semester.

2014 - 2015 - syllabus:-

- (i) To provide op- for the students to choose specialization in the IInd semester itself.
- (ii) To include one specialization paper namely Labour welfare and Labour Legislation, medical Social Work, Rural Community development in the IInd Semester instead of providing it in IIIrd Semester.
- (iii) To include Block field work (50 marks, 2 credits) and Summer placement training (50 marks, 3 credits) in II Semester, which is only internal valuation.
- (iv) To provide the paper Social policy and Social Welfare administration in the IIIrd Semester instead of providing in the IInd Semester.

- (V) To modify Unit V in the paper Medical Social work in the IInd Semester.
- (VI) To modify Unit V in the paper Social development in the IIIrd Semester.
- (VII) To completely reframe the mental health paper in the IV Semester.
- (VIII) To include pre-employment training and Rural Camp as the course requirement.
- (IX) To change the title of the paper Human personality development and human behaviour as Dynamics of Human behaviour in the Ist Semester.
