MINUTES

The Board of Studies meeting for academic year 2015-2017 commenced on HIB department around 10.30 a.m. The chairman of BBS Mr. G. Vignesh, Head HIB introduced and initiated the Board. Dr. G. Chandrasekaran, University nominee, Dr. G. B. Karthikeyan Subject expert as well as Academic auditor, Mr. B. Senthilkumar, Industrial expert, Mr. S. Arandan, Alumni member are the external members to the board. Mr. A. Kokila, Mr. N. Bhuvaneshkumar, and Mr. S. Saranya are the internal members.

The syllabus for the students those who are admitted from 2015 were discussed and the following changes were made:

- 1) Uniform coding for the entire syllabus framed by CBC, VVM College was made.
- 2) Non-major elective have become mandatory and a paper named International Business 15P15001 is introduced in II Semester.
- 3) The papers Financial Report Analysis, Statistical Techniques and operation Research and Industrial Training were removed.
- 4) The major research project is given eight credits and it is evaluated for 200 marks in the II Semester.
- 5) Changes in papers Logistics and Freight management and Supply chain management were made.
- 6) Mini Industrial visit project has been introduced in II Semester but the students has to undergo training during their II Semester holidays and name of Risk management and Insurance is changed into Global Risk management and Insurance.
- 7) The papers International Business Relation is shifted from I Semester to II Semester and International Economics is shifted from II semester to III Semester.

8.) It was suggested by the board unanimously that candidates may be permitted to undergo project work if they complete minimum seven industrial visit and one mini industrial project.

University nominee, subject expert as well as Academic auditor, Industrial expert and Alumni invite highlighted about the genuine work of HIB department in publication of articles, bulfledged syllabus, practical enrichment and vivavo in each semester and creating Entrepreneurship in the minds of students.

All the members are happy and the official closure of BOS was made around 3.00 p.m by the chairman.
