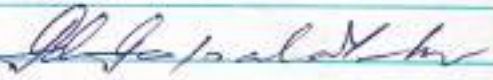
- Planned to collect more addresses of the Alumni Members in order to further strengthen the Alumni Association

- Next Executive Committee meeting will be held on Wednesday, the 27th January, 2016.

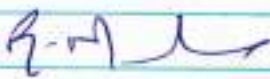

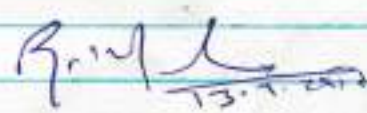
The Alumni Executive Committee meeting was held on Wednesday, the 09th March, 2016 at 5.00 p.m. in our College Board Room.

The Secretary of NGM Alumni Association Dr. R. Manicka Chezian welcomed the gathering.

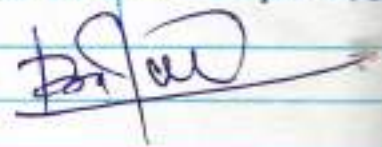
