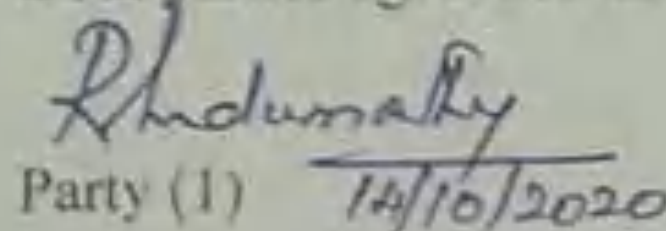

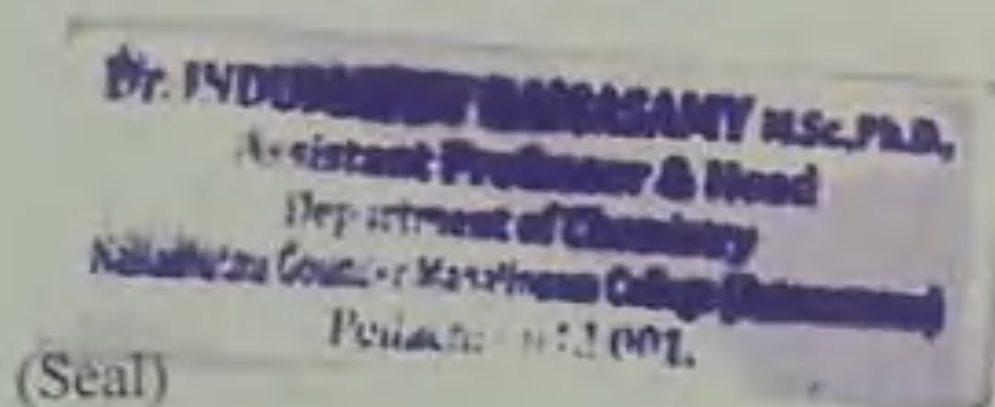

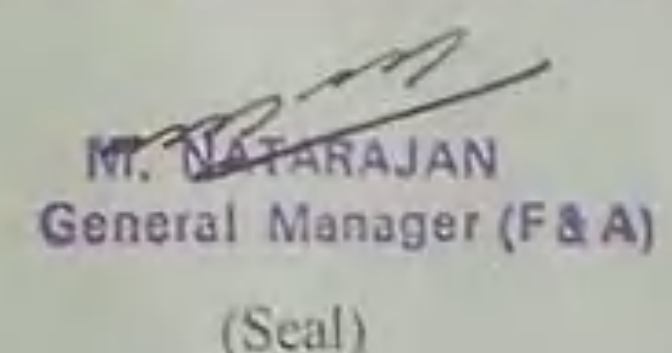

Both parties agree for this agreement for two years, starting from 14.10.2020.

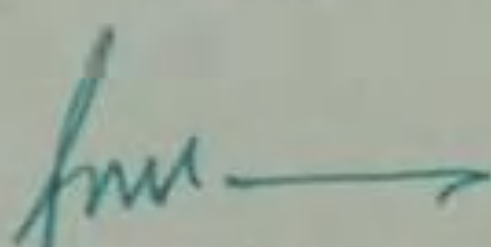

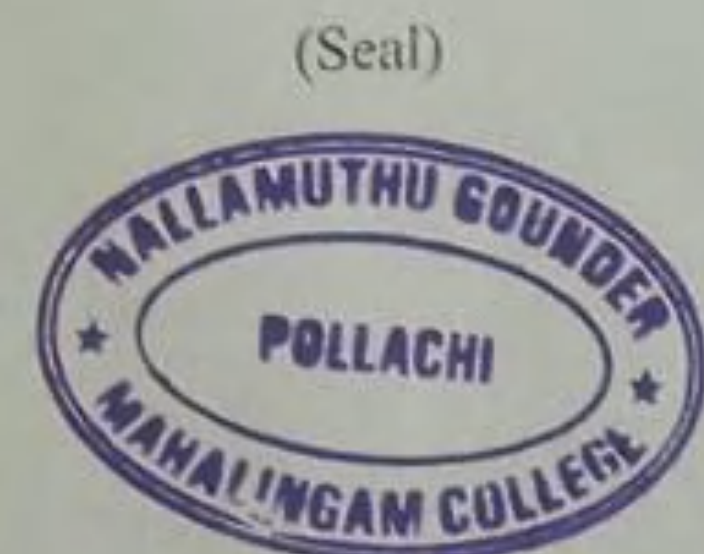

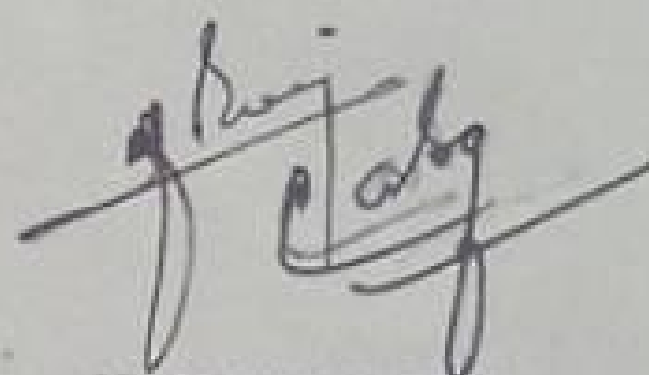
