


Fig 1: Organogram of Research Advisory Committee

2.2 Seed Money

- If progress is deemed unsatisfactory, the committee will document reasons and propose corrective actions.
- ❖ Failure to submit three consecutive reports will result in fellowship cancellation.

3.3 Guidelines for Seed Money

- ❖ All faculty members, whether working alone or collaborating inter departmentally, are eligible for funding. However, they must have at least two years of experience in research or teaching in a relevant field.
- * The project's duration is limited to maximum of one year, and the grant awarded per project is Rs. 25,000 or actuals.
- * The cost of hiring analytical services to complete a specific task within the project is included in the main grant amount.
- If approved, the purchase of equipment or consumables should comply with institutional norms.
- ❖ The final report of the research project should include:
 - Technical report along with the conclusion and research outcome
 - Audited statement of accounts
 - Audited utilization certificate
 - Plagiarism report







- ❖ The committee will conduct pre-reviews, ongoing monitoring and post-study assessments using established procedures such as annual and final reports.
- ❖ It will also verify compliance with all relevant regulations, guidelines, and laws.

4.3 Rules and Regulations for Plagiarism Check

Giving priority to check malpractices and plagiarism, NGM maintains the standards of research. The software that prevents plagiarism "**Plagiarism Checker X**" is available in the premises. It's mandatory for any researcher of the college to go for a plagiarism check before the submission of the thesis.

The following are the instructions given by university for researcher who goes for a plagiarism check.

- Only the scholar should personally present for Plagiarism check.
- Permissible similarity level is 10%.
- The similarity checks for plagiarism shall exclude the following:
 - All quoted work reproduced with all necessary permission and/or attribution.
 - All references, bibliography, table of content, preface and acknowledgements.
 - ➤ All generic terms, laws, standard symbols and standards equations
- The Plagiarism would be quantified into following levels in ascending order of severity for the purpose of its definition:
 - Level o: Similarities upto 10% Minor similarities, no penalty
 - Level 1: Similarities above 10% to 40% Such student shall be asked to submit a revised script within a stipulated time period minimum 1 month not exceeding 6 months

5. INTELLECTUAL PROPERTY RIGHTS (IPR)

Intellectual Property Rights protect and stimulate the creation and transfer of new knowledge, products and their applications for public benefit. IP includes patents, copyrights, trademarks, trade secrets, and tangible research property, as well as physical embodiment of intellectual effort such as machines, devices, designs, and biological materials.

- All investigations conducted at NGM utilizing the resources, the intellectual property rights resulting from such research shall be owned solely by NGM.
- Exceptions to this ownership occur when the investigations involve joint efforts with other institutions or agencies, or when conducted under the sponsorship of an external agency, where the utilization of NGM resources may not be explicitly evident.
- ❖ In the case of collaborative research endeavours undertaken jointly by NGM with external industries, organizations, agencies, or individuals, the Intellectual Property Rights (IPR) pertaining to inventions resulting from such collaborations shall be jointly owned by NGM and the respective collaborators.
- The costs associated with filing for IPR, maintaining IPR, and generating revenue from its commercial exploitation shall be shared between NGM and the collaborators based on a predetermined formula agreed upon.
- If collaborators are unwilling or unable to share the associated costs, NGM reserves the discretion to independently fund the filing and maintenance of IPR.
